# MISSION STATEMENT

The International Progressive Jewish network comprises Jewish organizations from the United States, Canada, Europe, Latin America, South Africa, and Australia. Together with Israeli organizations, we cooperate to provide a unified voice in support of democracy, religious pluralism, and a peaceful resolution of the Israeli-Palestinian conflict. The human and material costs of this conflict are tragic as attested by the humanitarian crisis in Gaza, continuing violence with loss of lives on both sides, and the threat to the very coexistence between Arabs and Jews inside Israel.

We believe in the deep values and principles of Judaism, which regards human dignity as sacrosanct and justice as an absolute imperative. Our shared values include the need to uphold pluralism and democracy so as to ensure the protection of minority rights and the coexistence of diverse cultural, ethnic, and religious identities in open societies. We are concerned by the increasing intolerance, xenophobia, and ultra-nationalism in the world. Building a global network of Progressive Jewry to oppose anti-Semitism and racism, which undermine democracy and tolerance internationally, is both a moral and an existential necessity.

We see a widening chasm between Jews from different regions of the world who are concerned with issues of human rights, equality and pluralism, and the growing number of Israelis who are leaning toward parochial nationalism. Many Jews involved in confronting anti-immigrant xenophobia and a rise in anti-Semitism are finding it difficult to reconcile these values with the illiberal and nationalistic spirit that prevails in Israel. We reject the Israeli Government's campaign to silence opposition to its policies by falsely equating criticism of Israel with anti-Semitism. Such a campaign weakens the struggle against true instances of anti-Semitism and, instead, strengthens the hands of anti-Semites worldwide.

We continue to believe in the values enshrined in Israel's Declaration of Independence, according to which the State of Israel as the democratic homeland of the Jewish people will ensure "complete equality of social and political rights to all its inhabitants irrespective of religion, race or sex." We are greatly concerned by racist and discriminatory trends that are taking hold in Israel. We oppose initiatives such as the Nation-State Law, which discriminates against non-Jewish minorities in the country.

We support movements and parties in Israel committed to ending the occupation and achieving peace between Israelis and Palestinians based on the right to self-determination of the two peoples. We aim to coordinate campaigns that mobilize Jews all over the world and Israelis who share progressive values, cooperate to defend democracy and the rule of law.

The International Progressive Jewish Network aspires to work with our respective local Jewish communities, our national governments and international organizations to advance the adoption of policies that promote justice, human rights, and a peace agreement between the peoples of Israel and Palestine.

# ANTI-ANNEXATION APPEAL: ENGLISH

As supporters of J-Link, the international network of progressive Jewish organizations, we urgently share our deep concerns, backed by the analysis of diplomatic and security experts, regarding the Government of Israel's intention to proceed with annexation of parts of the West Bank.

Only a short time remains to convince the Government of Israel to halt this ill-advised move. With the abetment of the Trump administration, Prime Minister Netanyahu is perpetuating the myth that reality on the ground supersedes international law. This is the moment that Israelis need to consider the consequences to their security and international relations, as a result of unilateral annexation.

Notably, a petition signed by 220 former senior officers of the army, the Mossad and the police who are members of Commanders for Israel's Security stated that annexation will set in motion a chain reaction over which Israel will have no control, leading to the collapse of the Palestinian Authority. This in turn would require Israel to take full control over the entire West Bank and assume responsibility for the lives of 2.6 million Palestinians.

The coalition agreement signed by Netanyahu and Alternate Prime Minister Gantz includes articles that enable the incoming government to expedite the process of annexation as of July 1st. Despite an acknowledgment of the need to discuss the matter with the international community, the only binding commitment in the agreement is coordination of the move with the U.S. Administration. As was the case with President Trump's "Peace to Prosperity" plan, the Palestinians have no say in the matter. It is worth noting that Article 28 of the Coalition Agreement mentions the government's intention "to strive to uphold existing peace agreements," indicating that Jordan and Egypt may have leverage over this decision.

For the Hashemite Kingdom of Jordan, heavily populated by Palestinian refugees, annexation risks destabilization that could endanger the government and compel it to reconsider its peace treaty with Israel. Israel's peace treaty with Egypt would also be put in jeopardy. Moreover, Israel's actions are already straining its relations with democratic countries around the world.

Unilateral annexation is illegal under international law and contravenes all relevant UN Security Council resolutions pertaining to the Israel-Palestine conflict, particularly UNSC Resolution 2334 of Dec. 2016. If implemented, annexation will signify the demise of the two-state solution and will dash any hopes the Palestinian people have of achieving self-determination through nonviolent means.

Furthermore, annexation could turn Israel into a state that maintains permanent control over millions of Palestinians within its territory – while denying them the most basic civil and political rights – thereby putting an end to democracy in Israel as we know it.

Such action risks provoking a mounting tide of delegitimization of Israel and further bouts of antisemitism. Annexation will also jeopardize relations between Israel and progressive Jews around the world for whom human rights, equality and democracy are essential principles.

Please join us in our call to all who care about Israel's future to take immediate action to convince the government and people of Israel that the price to be paid for annexation will be too heavy for Israel to bear.

# ANTI-ANNEXATION APPEAL: ITALIANO

Come membri e sostenitori di J-Link, la rete internazionale delle organizzazioni ebraiche progressiste, vogliamo condividere la nostra profonda preoccupazione, avvalorata dalle analisi di esperti diplomatici e di sicurezza , riguardo all'intenzione di Israele di procedere con l'annessione di parti della Cisgiordania.

Poco tempo rimane per convincere i governanti israeliani a rinunciare a questa mossa sconsiderata. Con l'appoggio dell'amministrazione Trump il Primo Ministro israeliano Netanyahu pretende di perpetuare il mito che la realtà sul terreno abbia più forza del diritto internazionale. Questo è il momento in cui gli Israeli devono attentamente considerare le conseguenze dell'annessione per la sicurezza regionale e le relazioni internazionali.

Una petizione di recente resa pubblica, sottoscritta da 220 ex alti ufficiali dell'esercito, del Mossad e della polizia membri dell'associazione "Comandanti per la sicurezza di Israele", afferma che l'annessione provocherà una reazione a catena al di fuori del controllo di Israele e condurrà alla disintegrazione dell'Autorità palestinese. Ciò richiederà a Israele di riprendere il possesso dell'intera Cisgiordania e di assumersi la responsabilità delle vite di 2.600.000 abitanti Palestinesi.

L'accordo di coalizione raggiunto tra Netanyahu e Gantz include articoli che consentono al governo entrante di accelerare il processo di annessione entro il 1 Luglio. Nonostante l'ammissione della necessità di discutere la questione con la comunità internazionale, l'unico impegno vincolante è quello di coordinarsi con l'amministrazione USA. Come è stato già per il piano di Trump " Peace to Prosperity", i palestinesi anche in questo caso non avranno nessuna voce in capitolo.

E' importante notare, comunque, che l'articolo 28 dell'accordo di coalizione menziona anche la volontà del governo di mantenere gli accordi di pace preesistenti, indicando con ciò che Giordania ed Egitto potranno esercitare un' influenza particolare nelle decisioni in materia. Per il Regno hashemita di Giordania, paese che ospita numerosi profughi palestinesi , l'annessione rischia di mettere in crisi il governo e di farlo riconsiderare il trattato di pace con Israele. Lo stesso trattato tra Israele ed Egitto rischia di essere messo a repentaglio. Inoltre, le azioni di Israele sono destinate a compromettere i rapporti tra questo e i paesi democratici nel mondo.

L'annessione unilaterale è illegale secondo il diritto internazionale e contravviene a tutte le risoluzioni del Consiglio di Sicurezza dell'ONU riguardanti il conflitto israelo-palestinese, particolarmente la risoluzione 2334 del dicembre 2016. Se portata a termine l'annessione significherà la fine della soluzione "due popoli due stati" e cancellerà per i Palestinesi ogni speranza di realizzare la propria autodeterminazione con metodi non violenti.

Inoltre in seguito all'annessione Israele diventerà uno stato che esercita un controllo permanente su milioni di abitanti palestinesi sul suo territorio, privandoli peraltro dei più basilari diritti civili e politici; ciò sarà la fine di Israele come paese democratico così come lo conosciamo. L'annessione non comporta solo la fine delle aspirazioni del popolo palestinese all'indipendenza, ma anche dei valori fondanti dello stato di Israele sanciti nella Dichiarazione di indipendenza del 1948. Vi è anche il rischio di un'ondata di delegittimazione di Israele e di ulteriori episodi di antisemitismo . L'annessione metterà in pericolo infine i rapporti tra Israele e gli ebrei progressisti nel mondo per i quali le ragioni dei diritti umani, dell'uguaglianza e della democrazia sono principi essenziali.

Invitiamo tutti coloro che hanno a cuore il futuro di Israele di unirsi a noi nel convincere il governo ed il popolo di Israele che il prezzo che Israele pagherà con l'annessione sarà troppo alto, insopportabile.

# ANTI-ANNEXATION APPEAL: ESPAÑOL

Como miembros y simpatizantes de J-Link, la red internacional de organizaciones progresistas judías, compartimos urgentemente nuestra profunda preocupación, respaldada por el análisis de expertos diplomáticos y de seguridad, con respecto a la intención del Gobierno de Israel de proceder con la anexión de partes de Cisjordania.

Queda poco tiempo para convencer al Gobierno de Israel de que detenga esta medida desacertada. Con el apoyo de la Administración Trump, el Primer Ministro Netanyahu está perpetuando el peligroso principio de que los hechos consumados en el terreno reemplazan el derecho internacional. Este es el momento en que los israelíes, deben considerar las consecuencias para su seguridad y sus relaciones internacionales, como resultado de la anexión unilateral.

Una petición firmada por 220 ex oficiales superiores de las FFAA, el Mossad, el Shabak y la policía, todos miembros de la ONG "Comandantes por la Seguridad de Israel" afirmó que la anexión pondrá en marcha una reacción en cadena sobre la cual Israel no tendrá control, lo que conducirá al colapso de la Autoridad Palestina. Esto, a su vez, requeriría que Israel tome el control total sobre toda Cisjordania y asuma la responsabilidad por la vida cotidiana de 2.6 millones de palestinos.

El acuerdo de coalición firmado por Biniamin Netanyahu y Beni Gantz incluye artículos que permiten al gobierno entrante acelerar el proceso de anexión a partir del 1 de julio. A pesar de incluirse una referencia general a la necesidad de discutir el asunto con la comunidad internacional, el único compromiso vinculante en el acuerdo es la coordinación de la medida con la Administración de los Estados Unidos. Como fue el caso con el plan de paz denominado por el Presidente de los EEUU Donald Trump como "El negocio del siglo", tampoco acá los palestinos no tienen voz en el asunto. Vale la pena señalar que el Artículo 28 del Acuerdo de Coalición menciona la intención del gobierno de "luchar por mantener los acuerdos de paz existentes", indicando que Jordania y Egipto pueden tener influencia sobre esta decisión.

Para el Reino Hachemita de Jordania, muy poblado por refugiados palestinos, la anexión corre el riesgo de desestabilizar y poner en peligro al gobierno y obligarlo a reconsiderar su tratado de paz con Israel. El tratado de paz de Israel con Egipto también se pondría en peligro. Además, las acciones de Israel ya están dañando sus relaciones con los países democráticos de todo el mundo. La anexión unilateral es ilegal según el derecho internacional y contraviene todas las resoluciones relevantes del Consejo de Seguridad de la ONU relacionadas con el conflicto israelo-palestino, particularmente la Resolución 2334 del CSNU de diciembre de 2016. Si se implementa, la anexión significará la desaparición de la Solución de Dos Estados y eliminará cualquier posibilidad que el pueblo palestino logre su autodeterminación a través de medios no violentos.

Además, la anexión –que no estaría acompañada por otorgamiento de derechos civiles– convertirá a Israel en un Estado que discrimina oficialmente al pueblo palestino por su origen étnico, poniendo fin a la democracia en Israel tal como la conocemos. La anexión es una sentencia de muerte no solo para las aspiraciones nacionales palestinas, sino también para los valores fundamentales del Estado de Israel, consagrados en su Declaración de Independencia. Dicha acción corre el riesgo de provocar una creciente ola de de-legitimación de Israel y ataques antisemitas en distintos lugares del mundo. La anexión también pondrá en peligro las relaciones entre Israel y los judíos del mundo para quienes los derechos humanos, la igualdad y la democracia son principios identitarios esenciales.

Únase a nosotros en nuestro llamado a todos los que se preocupan por el futuro de Israel para que tomen medidas inmediatas para convencer al gobierno y al pueblo de Israel de que el precio que se pagará por la anexión será demasiado alto para que Israel lo cargue.

# ANTI-ANNEXATION APPEAL: FRANÇAIS

En tant que membres et sympathisants de J-Link, réseau international d'organisations juives progressistes, nous souhaitons sans délai partager notre profonde préoccupation, étayée par les analyses d'experts en relations internationales et en sécurité, concernant l'intention du gouvernement israélien de procéder à l'annexion de certaines parties de la Cisjordanie.

Il ne reste que peu de temps pour convaincre le gouvernement d'Israël de mettre un terme à cette démarche malavisée. Avec la complicité de l'administration Trump, le Premier ministre Benjamin Netanyahu perpétue le mythe selon lequel la réalité sur le terrain l'emporte sur le droit international. C'est maintenant le moment où les Israéliens doivent réfléchir aux conséquences de l'annexion unilatérale sur leur sécurité et leurs relations internationales.

Une pétition signée par 220 anciens officiers supérieurs de l'armée, du Mossad et de la police, tous membres de l'ONG "Commandants pour la sécurité d'Israël" établit que l'annexion déclenchera une réaction en chaîne sur laquelle Israël n'aura aucun contrôle, conduisant à l'effondrement de l'Autorité palestinienne. Cela exigerait en retour qu'Israël prenne le contrôle total de toute la Cisjordanie et assume la responsabilité de la vie de 2,6 millions de Palestiniens.

L'accord de coalition signé par Benjamin Netanyahu et le président de la Knesset, Benny Gantz, comprend des articles qui permettent au nouveau gouvernement d'accélérer le processus d'annexion à compter du 1er juillet. Bien que soit reconnue la nécessité de discuter de la question avec la communauté internationale, le seul engagement contraignant de l'accord est la coordination de la démarche avec l'administration américaine. Comme dans le cas du plan "Paix pour la prospérité" du président Trump, les Palestiniens n'ont pas leur mot à dire. Il convient de noter que l'article 28 de l'accord de coalition mentionne l'intention du gouvernement "de s'efforcer de faire respecter les accords de paix existants", ce qui indique que la Jordanie et l'Égypte pourraient avoir un poids particulier sur cette décision.

Pour le Royaume hachémite de Jordanie, fortement peuplé de réfugiés palestiniens, l'annexion risque de déstabiliser le gouvernement et l'obliger à reconsiderer son traité de paix avec Israël. Celui avec l'Égypte serait également mis en péril. En outre, les actions d'Israël mettent déjà à rude épreuve ses relations avec les pays démocratiques du monde entier.

L'annexion unilatérale est illégale en vertu du droit international et contrevient à toutes les résolutions du Conseil de sécurité des Nations Unies relatives au conflit israélo-palestinien, en particulier la résolution 2334 de décembre 2016. Si elle est appliquée, l'annexion signifiera la fin de la solution à deux États et anéantira tout espoir du peuple palestinien de parvenir à l'autodétermination par des moyens non violents.

En outre, l'annexion risquerait de transformer Israël en un État qui maintient un contrôle permanent sur des millions de Palestiniens au sein de son territoire - leur dénier les droits civiques et politiques - mettant ainsi fin à la démocratie en Israël telle que nous la connaissons. Une telle action risque de provoquer une marée montante de délégitimation d'Israël et de nouvelles poussées d'antisémitisme. L'annexion mettra également en péril les relations entre Israël et les Juifs progressistes du monde entier pour qui les droits de l'homme, l'égalité et la démocratie sont des principes essentiels.

Nous appelons tous ceux qui se soucient de l'avenir d'Israël à agir au plus vite afin de convaincre le gouvernement et le peuple d'Israël que le prix à payer pour l'annexion sera trop lourd à supporter.

# ANTI-ANNEXATION APPEAL: PORTUGESE

Como membros e apoiadores do J-Link, a rede internacional de organizações judaicas progressistas, compartilhamos com urgência nossas profundas preocupações, endossadas pelas análises de especialistas em diplomacia e segurança, com vistas à intenção do Governo de Israel de iniciar com a anexação de partes da Cisjordânia.

Apenas um pequeno tempo resta para convencer o Governo de Israel a sustar esta ação impensada. Com a adesão da administração Trump, o primeiro-ministro Netanyahu está perpetuando o mito de que a realidade no terreno substitui a lei internacional. Este é o momento em que os israelenses precisam considerar as consequências para sua segurança e suas relações internacionais, como resultado de uma anexação unilateral.

Notadamente, uma petição assinada por 220 ex-oficiais seniores do Exército, do Mossad e da Polícia, membros dos ‘Comandantes pela Segurança de Israel’ (Commanders for Israel’s Security) afirmou que a anexação porá em movimento uma reação em cadeia, sobre a qual Israel não terá controle, levando ao colapso da Autoridade Palestina. Isto, por sua vez, demandaria que Israel assuma controle total sobre a Cisjordânia inteira e passe a se responsabilizar pela vida de 2,6 milhões de palestinos.

O acordo de coalizão assinado por Netanyahu e o porta-voz do Knesset Gantz inclui artigos que permitem ao novo governo iniciar o processo de anexação a partir de 1º de julho. Apesar do reconhecimento da necessidade de discutir a questão com a comunidade internacional, o único compromisso explícito no acordo é a coordenação da ação com a administração norte-americana. Como no caso do plano ‘Paz para Prosperidade’, do presidente Trump, os palestinos não terão qualquer palavra no assunto.

Deve-se notar que o Artigo 28 do Acordo de Coalizão menciona a intenção do governo de “lutar para manter os acordos de paz existentes”, indicando que Jordânia e Egito poderão ter influência sobre a decisão. Para o Reino Hachemita da Jordânia, com pesada população de refugiados palestinos, a anexação traz um risco de desestabilização, que poderia por em perigo o governo e compeli-lo a reconsiderar seu Tratado de paz com Israel. O Tratado de paz de Israel com o Egito também pode ser posto em risco. Mais ainda, as ações de Israel já estão estressando suas relações com países democráticos em todo o mundo.

Anexações unilaterais são ilegais sob a lei internacional e violam todas as resoluções do Conselho de Segurança da ONU pertinentes ao conflito Israel-Palestina, particularmente a Resolução UNSC 2334 de dezembro de 2016. Se implementada, a anexação significará a morte da solução de Dois Estados e anulará quaisquer esperanças do povo palestino em alcançar a autodeterminação através de meios não violentos. Além disso, a anexação transformará Israel num Estado que oficialmente discrimina contra o povo palestino baseado em etnicidade, privando-os de direitos civis e assim acabando com a democracia em Israel como a conhecemos.

Anexação é uma sentença de morte não apenas para as aspirações nacionais palestinas, mas também para os valores fundadores do Estado de Israel, consagrados em sua Declaração de Independência. Tal ação traria o risco de provocar uma maré crescente de deslegitimização de Israel e mais surtos de antisemitismo. A anexação também prejudicará as relações entre Israel e os judeus progressistas em todo o mundo, para quem direitos humanos, igualdade e democracia são princípios essenciais.

Por favor, junte-se a nós em nosso apelo, a todos que se preocupam com o futuro de Israel, para agir imediatamente para convencer o governo e o povo de Israel de que o preço a ser pago pela anexação será pesado demais para Israel carregar.

# INTRODUCTION

In response to the Israeli government's Coalition Agreement, dated April 20 2020, which included a proposal to unilaterally annex up to 30% of the West Bank as early as July 1, 2020, J-Link devised a strategy with its many international supporters.

In June 2020, the J-Link Coordinating Committee members, organized delegations to meet with Israeli Diplomats around the world, to express their concerns, as pro-Israel, pro-Peace, pro-2-state solution supporters. Each delegation presented the J-Link Appeal, signed by 50 progressive Jewish organizations worldwide, and asked the Diplomats to forward the Appeal to the Israeli Foreign Minister. This Report provides a brief summary of those meetings, including the Diplomats, members of the various delegations, and the significant outcomes.

## AGENDA FOR MEETINGS

**J-Link Delegations invited replies from each Diplomat on 4 key questions:**

- *Is the annexation part of the Trump Plan?*
- *Is the Israeli government still supporting the two-states policy?*

- *Is the Israeli government going to grant citizenship to the Palestinians living in the annexed territories?*

# SUMMARY OF RESPONSES

The J-Link delegations met with Israeli Diplomats from 21 different missions; however we noticed several recurring responses. In order to uphold the confidentiality of the meetings, we have summarized some of the most consistent responses and have not identified anyone's name. The following notes and opinions were expressed by Israel's Diplomats. J-Link's views on the proposed Annexation are explicitly stated in the Anti-Annexation Appeal that is signed by 50 progressive Jewish organizations worldwide.

**Arguments supporting annexation:**

- Israel has the support of its strongest ally, the USA
- Annexation is not a fait accompli
  - The Israeli government has not finalized anything
  - It has not even been brought up to a vote in the Knesset
- Will likely be a limited annexation
  - Seems to be a result of immense international pressure
- Annexation is a good option in line with a Two-State Solution

**With regards to Palestinians:**

- Palestinians must come to the table and negotiate
  - There is no one to talk to
- Palestinian severance of security coordination is dangerous to their own people
- No clear response as to the legal status of Palestinians on annexed land:
  - Including citizenship, voting rights, home demolitions, etc
  - The outlier includes one senior ambassador, directly related to Israeli leadership, stated that Palestinians living in annexed territories would receive full citizenship rights

# SUMMARY OF RESPONSES

**Internationally:**

- Israel's relationship with Jordan remains a high priority
- One senior ambassador cited the importance of the United Arab Emirate's opinion in Israeli decision making
  - Our delegations noticed a meaningful slowdown in preparation to annex after the OpEd by UAE Ambassador to Washington in the Yedioth Ahronoth newspaper

**Note on Ambassadors' Responses:**

- Israeli Embassies across the world did not have unified knowledge about annexation; several thought it would not happen while many admitted to be speculating responses. Some were not able to answer any of our questions while others gave specific answers, and some contradicted each other. Additionally, Jewish condemnation of the proposed Annexation has varied across and within countries. Most Ambassadors acknowledged that many people had reached out to them about this issue, but several mentioned that the J-Link delegation was the first time they heard of it directly.
